Jane Brown (Southeast RMG)

Jane has been involved as a volunteer in the Northeast Council of Boy Scouts in Georgia for over 36 years! She has been able to do this work during her retirement via email, Zoom and phone in addition to much commuting to and from Scoutland, Georgia on Lake Lanier and Camp Rainey Mountain. Jane has served in many positions on the council including Assistant Council Commissioner for over ten years.



Richard G. Shankle (Indiana RMG)

Richard has served as President of the Auburn/Waterloo Trail Committee through 2024 whose mission it is to upgrade the 6.2 mile trail to meet State of Indiana standards and to become part of the longer 81 mile Poka-Bache Trail, the longest in the state. Richard has been involved in fundraising including seeking grants from the state. Close to ten thousand guests used the trail last year and Richard hopes the completion of the trail upgrade will improve the quality of life for residents in Northeast Indiana.



Ross Willour (Southern Cal RMG)

Ross has volunteered for various causes as a 42 year member of the Knights of Columbus including the Wheelchair Mission operated by Chris Lewis (son of Jerry Lewis), the Frank Nigro Foundation assisting people with intellectual disabilities, and currently President of the Board of the Columbian Retirement Home Inc., a nonprofit corporation of the Knights of Columbus which owns and operates a twenty unit independent living facility for seniors fifty-five and over.
