







## J.C.Penney Gets His Start

Longmont has a rich history in agriculture, but many don't realize that retail legend James Cash "J.C." Penney got his start as a small business owner on Main Street in downtown Longmont.

James Cash "J.C." Penney came to Denver in 1897, leaving his hometown of Hamilton, Missouri on his doctor's advice to take advantage of the dry air. Missing the small-town charm of Hamilton, he shortly made his way north to Longmont.

When Penney arrived in Longmont, he took his life savings of \$300 and bought part ownership in a butcher shop located at 331 Main Street (currently Love's Bakery). In 1898, he purchased his partner's half of the business, and changed the name to the James C. Penney Meat Market. The market's biggest customer was Longmont's fanciest hotel, the Zweck Hotel, today referred to as the Imperial Hotel, located at 301 Main Street. The cook would buy all his meat from Penney's market as long as he got his "tip" each week – a bottle of bourbon. Penney delivered one bottle and refused to deliver anymore, so the hotel took their business elsewhere, and Penney's meat market closed within the year.

In December 1898, Penney went to work for Tom Callahan at his dry goods store, The Golden Rule, located at 372 Main St. (currently Crystal Joys). Penney worked hard, and Callahan took notice offering him one-third interest in a new store opening in Evanston, Wyoming. So in 1899, Penney married Longmont resident Berta Hess, and began working at the Wyoming store.

In 1902, Callahan and his partner Guy Johnson, offered Penney a partnership in a store they were opening in Kemmerer, Wyoming. Penney accepted, and in 1907 he officially bought the Kemmerer store and two others (Rock Springs and Cumberland, Wyoming) from Callahan and Johnson for \$30,000. He changed the name of the stores to JCPenney, a chain of dry goods stores that became very successful.

Penney made his way back to Longmont in 1917 when he opened his 169th store at 315 Main Street (the store





bounced around many downtown locations including 460 and 434 Main St.) The store remained in downtown Longmont until 1985 when it moved to the Twin Peaks Mall (which closed in 2014) and had relocated to 955 South Hover Street. That location closed in June 2017. Penney resigned as president of his Company in 1917, but he remained an active member of the board of directors until he died in 1971 at the age of 95.

Penney was determined and hard-working, and he made a name for himself by being ethical and honest. When asked about his first business, he would often say, "Thank God I failed as a butcher..."

"I do not believe in excuses. I believe in hard work as the prime solvent for life's problems." –James Cash Penney


JCPenney believes that access to nutritious food is essential for good health and well-being. In 2022, the Company pledged \$500,000 over the next three years to support child hunger programs through Feeding America, a nationwide network of 200 food banks, 21 statewide food bank associates, and 60,000 partner agencies, food pantries and meal programs. The partnership with Feeding America is part of the Company's ongoing commitment to help end hunger and ensure that everyone has access to nutritious food.

The National H.C.S.C. Alumni Club is asking for the support of all 12 Regional Meeting Groups (RMG) and its members to plan a volunteer event at a local Feed America food bank partner during October, November and December. We believe this is a great way to give back and support our local communities across the country and to support Mr. Penney's vision of Honor, Confidence, Service and Cooperation.


Each RMG President will assign a point person who will communicate via email the volunteer opportunities that are available nearby. Volunteer shifts are roughly three hours including orientation and helping to sort and pack food and products.

## JCP Returns to Legacy Building

On July 20, JCPenney officially welcomed associates back to the office with a ribbon cutting of its new corporate offices at the Campus at Legacy West (CALWest). A long-standing member of the North Texas business community, JCPenney's return to its Plano campus marks a transformative moment for the Company as it drives its hybrid work strategy forward, supporting and accommodating the diverse personal and professional needs of its many corporate associates.

The homecoming committee planned events throughout the week to welcome associates back, culminating with a ribbon-cutting ceremony and reception attended by associates, business and nonprofit partners, elected officials and neighbors from the Plano business community.

JCPenney Chief Executive Officer Marc Rosen, Chief Human Resources Officer Andre Joyner and Texas Representative for District 66 Matt Shaheen addressed associates, emphasizing the importance of the associate experience and the Company's place in the Plano community. In honor of the grand opening and as part of JCPenney's three-year partnership with Feeding America, the program concluded with a check presentation to Feeding America from JCPenney for \$175,000 to help address food insecurity in communities across the United States.

JCPenney welcomes back more than 2,000 associates to the 320,000 square foot CALWest campus, in the same building where the Company operated for 28 years prior to the pandemic. The reopening is part of JCPenney's continued efforts to enhance the associate experience and remain a visible leader in the local business community.

"It's important that our corporate headquarters provide an environment where we can collaborate and create, accommodate diverse personal and professional needs, and live and experience the JCPenney brand firsthand," said Andre Joyner, chief human resources office for JCPenney. "CALWest offers all this and more, and although we called this building home for 28 years, there's lots of new things to discover under its new ownership group, Capital Commercial Inc."

The new office is an open working environment, designed to encourage collaboration among colleagues and connection to the JCPenney brand. Beyond the modern design and new technology aimed at fostering a seamless hybrid workforce, CALWest offers best-in-class amenities for our associates, including two pickleball courts, an arcade, state-of-the-art fitness centers and a golf simulator.

David Kruger's historical buildings tour included the site of the First Golden Rule Store (1902), the Second Golden Rule Store (1903), Mr. Penney's Home and Museum, the JCPenney Mother Store #1 (1929) and Mr. Penney's Bronze Statue (formerly in the JCPenney Home Office in Plano, Texas).

The program was conducted by Trista Gordon, Kemmerer Recreation and Special Events Director, and had many notable highlights:

- Remarks by Senior U.S. Senator from Wyoming, John Barrasso
- A presentation of a \$10,000 check by Angela Marshall Hofmann, Head of Government Relations, from the JCPenney Communities Foundation to the James Cash Penney Home and Museum
- A presentation of a \$7,500 check to the James Cash Penney Home and Museum by the granddaughters of Mr. Penney representing nine grandchildren.
- The presentation of the first ever Golden Rule Awards by the City of Kemmerer to two deserving Lincoln County citizens who were selected from 17 nominees.

A special display was set up in Triangle Park with a petition to nominate James Cash Penney for a 2025 U.S. Postal Service Commemorative Stamp in honor of the 150th Anniversary of his birth. Lincoln County citizens enthusiastically signed the petition to be sent to the USPS Citizens Stamp Advisory Committee in the near future.

### James Cash Penney Commemorative Stamp Campaign Update

#### Dear Partners,

Below find the latest updates from our effort to have the USPS Citizens Stamp Advisory Committee approve a 2025 Commemorative Stamp to honor Mr. Penney on the 150th Anniversary of his birth:

- 1) Angela Marshall Hofmann, Head of JCPenney Corporate Relations, has been working with the Governor's Staffs of Missouri, Texas and Wyoming to have the Governors write a letter of recommendation. No progress reports yet, but Angela is continuing to motivate the Governors and their staffs.
- 2) Our Alumni Club built a petition program that was implemented in Kemmerer for the 3rd Annual Golden Rule Days. We acquired 46 signatures from citizens of Lincoln County and we will mail the petition with explanatory documents to the USPS Citizens Stamp Advisory Committee. We will then be looking for other locations to have the petition signed in the coming year.

Special Note: If your RMG would like to have a petition drive at one of your group's events, a petition form can be emailed to you. All petition forms are to be sent to this address when properly completed (see instructions on the petition itself.) Please include a letter of nomination.


## New Database Feature


New sign in process for the member database!

Next, enter in your password and the captcha.



## Mark Radman


Mark Scott Radman was born on June 22, 1957, in Uniontown, Pennsylvania, about 60 miles south of Pittsburgh. His father, Daniel, owned a men's clothing store and his mother, Rosalind, taught school and also worked in the store. Mark has one sister, Barbara, who is three years younger, married with three children, two grandchildren and currently lives in Plano. Mark moved to Dallas to attend Southern Methodist University. In 1979 he earned his BA degree in English with a "Creative Writing Specialization." In 1981, he received his MBA from SMU's Cox School of Business. Mark also completed the Rice University Publishing Program gaining continuing education credit hours in book and magazine publishing procedures.

Mark worked in the circulation department for Dallas Photo Magazine and Portfolio Publishing Company before becoming an Accounting Manager and then advancing to Assistant Controller for Southwest Media – publishers of D Magazine, Houston City Magazine, Texas Homes Magazine and SPORT Magazine from 1982 to 1987.

Mark started working in retail in his father's store while growing up and during college worked part time as a salesman for Culwell and Son. Over the last 20 years, Mark has worked for JCPenney, starting in family footwear at the Valley View Mall in June 2000. (Barger Tygart was the store manager.) Mark remembers in those first years getting \$.50 for selling a catalog book. He also remembers Allen Questrom's visits to the mall around JCPenney's 100th Anniversary, the launch of the American Living Brand, and JCPenney's helping to raise awareness for children after school care by sponsoring "The Concert for America's Kids" and Rascal Flatts tour.

In 2005, Mark transferred to JCPenney's Town East Mall Store 2338 in Mesquite, Texas, as a selling specialist in men's clothing. He was part of the team when JCPenney's private label, Stafford, grew to sales over a billion dollars. In June 2020, Mark was eligible and accepted the Voluntary Early Retirement Program. While most retail companies do not offer a pension plan for retail shop clerks, Mark was eligible even considering he worked primarily part time!

In July 2021, Mark returned to work part time as a sales floor associate at Town East Mall JCPenney (Chris Macfee was the store manager) and continues to work periodically, including most recently for the back-to-school tax-free weekend.

This event served as somewhat of a "circle of life" event for me. It was in Columbus that I was born, started my career, married, and started a family. So, it was exciting to go back home and welcome our group there.


#### **CAREER YEARS**

My career with JCPenney was never planned or intentional. In fact, I never even filled out a job application. My dad was a police officer in Columbus and worked an off-duty job as Director of Security at the local mall. Through that job, he developed an intense respect for local Penney Manager Bud Ruffner and always said that he would love for me to work under Mr. Ruffner's leadership.

One day Dad and I were walking through the store and ran into Mr. Ruffner. I was only 16 years old, but Dad mentioned that I was looking for a summer job. I didn't really expect anything to come out of that. But a few weeks later, I received a phone call from the store asking if I could come to work that day- June 29, 1970, on the Auto Center Gas Island. My intention was to work only until Labor Day when school started, but I ended up staying over 37 years through eight relocations spanning five states. Not a bad summer job.

The Gas Island was a dream job for a high school kid. I absolutely loved it. I think I would have been happy to do it for the rest of my life. Little did I know that one day, gasoline would become a self-serve commodity and there would be no need for us gas nozzle jockeys.

After a couple of years and graduation from high school, my role expanded to stockroom and custodial duties in addition to my Gas Island duties. It was during that time that I noticed a beautiful girl named Becky Dixon working in the Misses Sportswear Department and, as they say, the rest is history. A half century later, she is still the best thing that ever happened to me. While we were dating, I was offered the opportunity to move to the sales floor as an Automotive Selling Specialist and found that I could make some pretty decent money in commission sales. And the opportunity to work in a dress shirt and tie instead of a work uniform was pretty exciting. During those three years,

I worked full-time, attended college in the evenings, got married, and had a beautiful baby girl.

So, in 1976, when I was offered the opportunity to enter the Management Training Program in that store, it was not an easy decision. I understood the possibilities and wanted to do it, but the pay cut it would involve was tough to accept. Fortunately, with Becky's support and encouragement, I accepted the offer. And again, the rest is history.

My first management assignment was a move to the Atlanta market as Assistant Manager of the freestanding Auto and Garden Center at the Forest Park Catalog Distribution Center, Just four short months later. I was moved across town to the South DeKalb store where I worked as Auto Center Manager for Store Manager Charlie Haygood. During my two years in that assignment, the highlights were being a test unit for the development of the RMM4 Merchandising System for Auto Centers and leading a massive Catalog Surplus Liquidation Sale that produced the largest Auto Center volume day in Company history. Not everyone was happy with that event- most notably Regional Manager John Wells. But we survived that, and I managed to get moved out of the Auto Center and into the main store managing hardlines before I had to fight those figures the next year.

After South DeKalb came another move across town to Northlake for a year managing hardlines. During that assignment came the birth of our second child who made

the news as the first birth of the New Year in Henry County, Georgia, in 1982. Shortly afterwards, I was placed on Special Assignment closing the Atlanta Auto Centers. That was emotionally the hardest assignment I ever had as we had to say goodbye to many great associates.

After those closings were completed, I had the unusual blessing of being transferred back to my hometown of Columbus, Georgia, to again manage hardlines and work for Mr. Ruffner. When the Company made the decision to discontinue those lines nationwide in early 1983, I was offered my first assignment in soft lines managing Women's Apparel and Women's Accessories. It was quite a steep learning curve for a guy who had always been in hard lines, and I was the only male managing Women's in the District. And to make it worse, I was given a supplemental assignment to travel two days per month as a compliance auditor of Firestone stores to assure they were following JCPenney Battery adjustment procedures. The goal of that team was to slow the profit hemorrhaging from the JCPenney Lifetime Battery fiasco. Needless to say, we failed.

After surviving that, I got my first second level assignment in that store as General Merchandising Manager (GMM) in 1986 and after a couple of years was transferred to Dover, Delaware, as GMM reporting on New Years Day 1989. That was a pretty overwhelming move for a guy who had never lived outside the state of Georgia. But working for Store Manager Warren Richards was an outstanding experience.





Warren and I would remain close and worked on several charity projects together in retirement.

After a couple of years in Dover, I was transferred to Richmond, Virginia, as the District Men's Division Business Planning Manager (BPM) and then in 1993 to the Richmond District Office as District Operations Manager for District Manager Charlie Haygood. So, in my last assignment before becoming a store manager, I had the same boss that I had in my first assignment as a department manager- a young Store Manager Charlie Haygood in the 1970s and a seasoned District Manager Charlie Haygood in the 1990s.

My first store manager assignment was Carrollton, Georgia, from Fall 1994 to Spring 1997 where I also served as Women's Entity Manager for the district. The Carrollton team won the Chairman's Award twice in those three years and I was fortunate to be along for the ride. And it was great being back within 90 miles of home.

Then followed a move to manage Johnson City, Tennessee, from Spring 1997 to the beginning of 2002 where I also served as Host Manager for the Northeast Tennessee Central Receiving Stockroom. During that time, the store achieved the highest sales per square foot ranking in the Company. Every day presented another space challenge. But we had a great team there that got it done and allowed me to win the Store Manager of the Year award in the Birmingham, Alabama district for 2001.

My final move came in 2002 to manage the store in Little Rock, Arkansas, where I remained until retirement. A highlight from that store was becoming the only store in the Company to make its credit app goal every month for five straight years.

#### RETIREMENT YEARS

Just before retirement, I was appointed to the Maumelle, Arkansas Civil Service Commission where I served as chairman for eight years. After retirement, I spent seven years with the Arkansas State Fair Association in Little Rock working with the rural youth of the state. That proved to be interesting in that I had never lived in a rural setting in my life, but I loved both the people and the work.

During that time, we also became heavily involved in volunteer staff work at our church. A highlight of that time was leading a two-year effort called Mission Mayflower which served the small town of Mayflower, Arkansas, following a devastating tornado. As part of that, we developed and led a school mentoring effort there that received statewide recognition for its impact on children in need of extra attention. It was truly a blessing to be part of that.

In 2017, the urge to be closer to family led us to move back to the Northeast Tennessee area which was our favorite spot from all of our moves. We have a two-acre yard that I take care of myself so that occupies a lot of my time. Also,

## For the record books

In 1974 I was part of the management team in JCPenney Store 1579 outside Marysville, California. Many of our customers were stationed at or worked at nearby Beale Air Force Base. Beale was home to a Strategic Air Command wing and the super-secret Lockheed SR-71 "Blackbird".

During the late summer of 1974, the Air Force announced plans to attempt to set a speed record flying the SR-71 from New York to London. After the flight, the plane would be on public display for the first time at Farnborough Air Show. The flight crews would, of course, wear their Air Force uniforms, but the ground crews attire presented a problem. The ground crew was a combination of Air Force and Lockheed personnel, so they needed a different solution for matching apparel.

Because my merchandising responsibility included the Men's Department, I was contacted and asked if JCPenney could on short notice provide Big Mac Super Klondike matched sets in navy for the ground crew. It was a mad scramble, but we found the various size combinations in time to clothe the ten-man crew.

On September 1, 1974, the SR-71 flew from New York to London in 1 hour and 55 minutes. The average speed was over 1,800 miles per hour. The record still stands today and JCPenney figuratively went along for the ride.

### Murray, Kentucky from Pat Phillips

In 1982 my husband, Earl Lynn Phillips, got his first JCPenney store to manage! It was also the first JCPenney store in Murray, Kentucky, so lots of excitement. He went on to Kentucky while the store was being built, we stayed in Stone Mountain, Georgia, for our three sons to finish the school year, joining him as soon as possible. In July the boys and I went to Arkansas to see their grandparents. When we returned, the 'grand opening' was looming, but Lynn was determined to come home and have lunch with us. He didn't arrive and a little later the phone call came to go to the hospital, there had been an accident.

New shopping center, new traffic light...a loaded gravel truck had sped through a red light as my husband was pulling out, running over our old Volvo wagon, spinning it back and hitting it again. He survived with a concussion, broken collar bone, cracked ribs all the way down his spine, and bruised head to toe. He thought he HAD to be at Grand Opening. He had to be back in the store with employees and customers, but when he realized he could not, he insisted I be there to represent him at the ribbon cutting. I did not want to leave him, but he was adamant, so I was there! My question all these years later, "was I the only wife who got to open a new store in place of their husband?"

Just to follow up, that man made me take him to the store on the way home from the hospital. He managed to walk to his office, greeting employees, sat down long enough to catch his breath, then we walked back. He had me drive him in every day, staying longer each time, until he could drive himself. Our time in Murray were wonderful days for each of us and as a family. Thankful for the Penney family, our church and the community!






